PROGRAM:

The March late afternoon program will once again precede our business meeting. The topic is "Small Plastic Pool Container Production of Cucumbers"

Dr. Leigh Whittinghill Dr. Leigh Whittinghill is a horticulturalist with expertise in vegetable production and green roofs. Her research focuses on urban agriculture, novel production systems that could help increase production area and reduce costs, and the potential environmental impacts of urban agricultural practices.

Dr. Whittinghill's doctoral research at Michigan State University focused on the use of green roof systems for food production, examining both crop yields and the potential impact that crop production could have on the known benefits of green roofs.

MINUTES OF THE FEBRUARY 20TH MEETING:

The afternoon began at 1 pm with a presentation by Dr. Susanna Keriö of the CT Agricultural Experiment Station, discussing the science behind mycorrhizal fungi and their use as soil additives in the growth of urban trees.

She discussed in particular the ongoing research in eight CT cities, including Middletown, where she is comparing red maples, redbuds, and lindens grown with and without mycorrhizal additives.

Following a lengthy Q and A session, President Wuestefeld thanked Susanna and called the meeting to order at 2:35 pm. She also thanked Laney and Judy for their delicious array of treats and beverages, and the beautiful flower arrangement.

With no corrections or additions, the minutes of the November 2024 and February 2025 meetings were approved unanimously. On a motion by Kathie Green, with seconding by Jane Harris, the February Treasurer's report was also approved unanimously, with many thanks to Lynn for her hard work. She again thanked Rhea for her wonderful presentation in January; Lynn said that the Durham librarian reported a strong favorable response to our meeting there, and we are invited to return, possibly with a joint program involving the Durham Garden Club.

Committee Reports:

Admissions: Kathy Meyering said that, in an effort to attract some younger members, the next two meetings will be held at 5 pm. Members are encouraged to bring one or more friends who might be interested in joining.

Archives: The scanning continues – Kathie reports she is up to the 1980s.

Civic Improvement/Founders Fund: Laney and Kim reminded members to read the descriptions of the Founders Fund finalists (in the Winter Bulletin and on page three of this month's Cornus) so that we can take our club's vote in March.

Communications: Debby read thank you notes from Mary Xenelis and from the Friends of Long Hill Estate, thanking the club for memorial contributions for Ted Xenelis and Maria Holzberg.

Conservation/NAL: Sally reminded members that they can attend several NAL events online this year March 23-26; a keynote address by Bill McKibben is one of the highlights. Tisha reminded us to follow two very important bills in the CT General Assembly: Raised Bill 6196 to ban Neonicotinoids (submitted by former Middletonian Linda Bowers) and Raised Bill 9615, to ban rodenticides using blood thinners, which kill birds and cats as well as rodents.

Flower Arranging: Kate said that Fine Art & Flowers will be held at the Wadsworth Atheneum April 25 – 27.

Horticulture: Kathie reminded members who received seeds for the Gavel Challenge that sowing for the first batch will begin soon. More seeds can be ordered if anyone wants to join in.

Visiting Gardens: The club will visit the fabulous <u>orchid show at NYBG</u> on April 1. The exhibit is open from February 15 through April 27.

New Business: Arbor Day will be celebrated April 25 at 10 am at the Wadsworth Mansion. There will be no Earth Day event this year at Harbor Park, but individual businesses will hold events around town.

FOUNDERS FUND FINALISTS:

Marshlands Conservancy – Remediation of the Critical Meadow Habitat

Proposed by: Little Garden Club of Rye, Zone III

Seconded by: Rye Garden Club, Zone III

Marshland Conservancy is designated as a critical habitat and bio-reserve for the preservation of species. It is a natural laboratory for ecology, botany, and conservation. To nurture more native, slower growing plants and repel invasives, the cataloging of these species is critical to the overall remediation. The planned trailside herbarium will require tools such as high resolution equipment and reference library storage files for vouchered reports to be published in the NY Floral Atlas to document reestablished species as the meadow is remediated.

The Virginia War Memorial Green Space Project

Proposed by: The Tuckahoe Garden Club of Westhampton, Zone VII

Seconded by: The James River Garden Club, Zone VII

The Virginia War Memorial is located on five acres of property adjacent to downtown Richmond. The Memorial welcomes 100,000 visitors each year paying tribute to the nearly 12,000 Virginia veterans from WWII to present day who have died during their service in the military. The grounds have been barren of shade trees, native plantings and pollinators. The landscape plan developed for the Public Green Space Project includes more than 1,000 trees and shrubs.

Forsyth Park Educational Shade Garden

Proposed by: Trustees' Garden Club, Zone VIII

Seconded by: Peachtree Garden Club, Zone VIII

Savannah's historic Forsyth Park presents an exceptional opportunity to showcase a private/public partnership in urban planning focused on shade for a densely populated community. A Founders Fund grant will help establish an educational shade garden within the park to provide cooler temperatures, human health care and environmental benefits, and an extension of those benefits to millions of users - especially residents most affected by heat, stormwater and lack of green space.
